6. PLANNING APPLICATIONS TO BE DISCUSSED (AT TIME OF SENDING OUT NOTICE).

23/00610/FUL. Albion Hotel, Gate Lane, Freshwater Bay.

Proposed single storey extensions on west and south elevations; porch canopy; internal alterations to form staff accommodation; alterations to fenestration and balconies. (revised description) (readvertised application).

Freshwater Parish Council approve the application, supporting the conditions, and the AONB comments in respect of lighting.

23/00720/FUL. Pebbledash, Guyers Road, Freshwater.

Demolition of rear extension; proposed single storey extension.

23/00780/FUL. Albion Hotel, Gate Lane, Freshwater Bay.

Proposed extension to form spa facilities, alterations to car park and proposed solar panels.

23/00783/FUL. Freshwater Lifeboat Station, Freshwater Bay.

Partial demolition of side addition; removal of container; proposed extension to side, rear and first floor to provide improved facilities.
